
COUNTY OF BOSQUE

That the Fulton Cemetery, located in the D.RYAN SURVEY, ABSTRACT NO. A-0700 and the W.H. SMITH SURVEY, ABSTRACT NO. A-0749, Bosque County, Texas and more particularly described in *Exhibit A* as attached hereto, has been set aside and dedicated for cemetery purposes through historic use and that such property is now occupied by human graves.

That this dedication is subject to all the laws, rules, and regulations of the State of Texas regarding cemeteries now in effect and to those adopted after the effective date of this dedication, and is made in accordance with 13 Tex. Admin. Code Section §21.30.



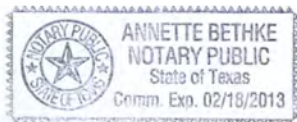

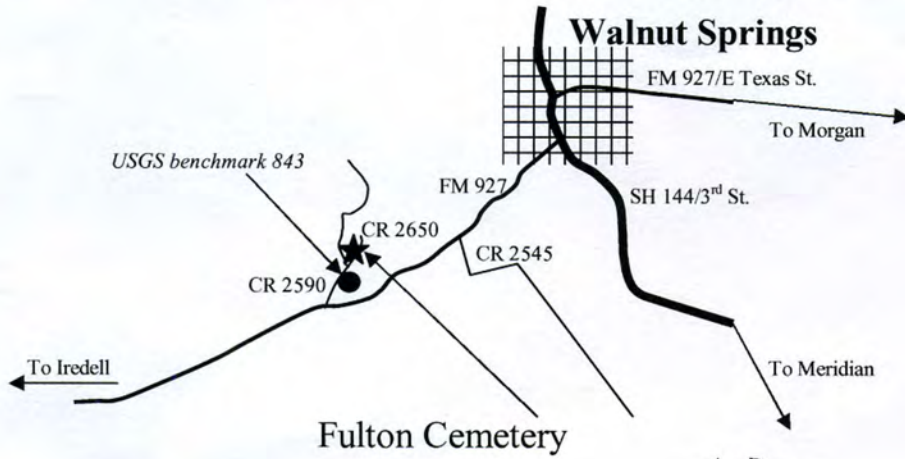


Location Map

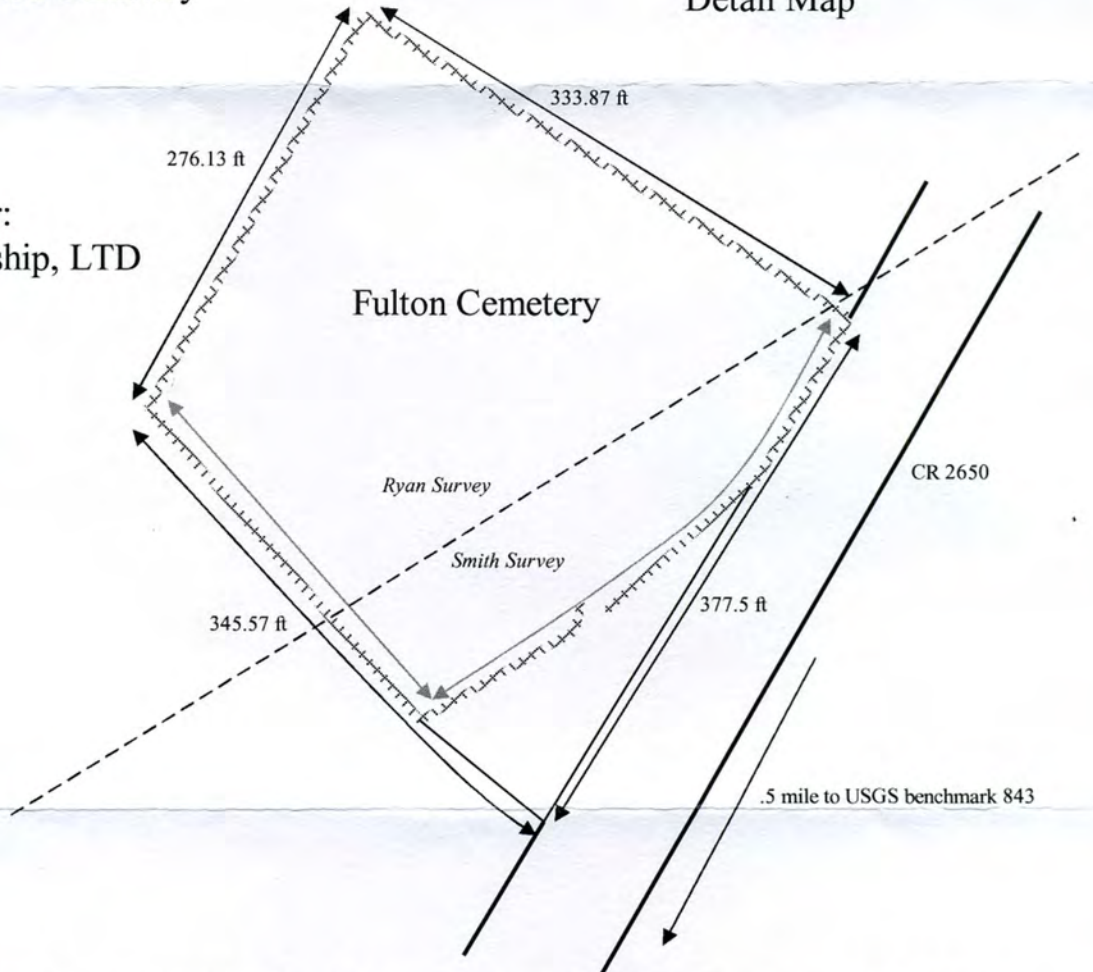
